DESCRIPTION OF REQUIREMENTS

1. The United Nations Interim Force in Lebanon (UNIFIL) intends in the future to solicit proposals for Estalishing a One-time purchase of Sports Equipment to DAP UNIFIL HQ, Lebanon.

The interested bidders must comply to the Mandatory requirements which will be detailed in the bid invitation that will be sent to the interested bidders:

2. The United Nations Interim Force in Lebanon (UNIFIL) requires a Contractor to supply and deliver Sports Equipment to DAP UNIFIL HQ Naqoura, South Lebanon based on a one time purchase as per quantities and specifications that will be required.

3. The full TEC, Bill of Quantities (BOQ), and other relevant documents will be provided at the future solicitation stage of Request for Quotation (RFQ).

4. By expressing interest, vendors must ensure that they are registered in UNGM or will be registering



before participating in any possible future solicitation process. Those companies not registered with United Nations Global Marketplace (UMGM) cannot be included in the List of Invitees . Registration with UNGM (WWW.UNGM.ORG) is free of charge and mandatory for all companies wishing to participate in the UN solicitations.

5. Required is that companies responding to this EOI have UNGM registration identifying 'UN Secretariat' as a selected agency at minimum, Basic Level, with the understanding that the eventual awardee will be expected to meet Level 1 or Level 2 registration status.

6. UN reserves the right to issue the final solicitation documents only to those prospective Vendors that respond to the EOI, and are deemed qualified upon completion of an objective evaluation of their submission, or to change or cancel the requirement at any time during the EOI and/or solicitation process. Thus, submitting a reply to this EOI does not automatically guarantee participation in the eventual RFQ neither does it assure that a specific tender exercise will be undertaken in due course.

7. Please note that this request for EOI is not an invitation for submission of a Proposal. The RFQ and any subsequent commitment to contract will be issued in accordance with UN rules and regulations.

SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

8. The interested bidders must comply to the Mandatory Requirements which will be provided at the future solicitation and specifications that will be required.

a- Submission of Manufacturer's Catalogs/Brochures, Technical Data sheets/Specifications, Website, Web links, Brand name, Model, Part number, etc.... that explicitly indicate and contain relevant details of technical specifications for all lines items is a Mandatory Requirement.

b- Each Manufacturer's Catalogs/Brochures, Technical Data sheets/Specifications, Website, Web links, Brand name, Model, Part number, etc should clearly indicate a reference to the offered Line Item Number.

c- If multiple items of similar description are reflected in the submitted documents or links, etc..., the bidder MUST highlight the exact offered Model/Brand/Part number.

d- The provided documents should be in English language, cleary scanned and readable.

e- Failure to submit the relevant supporting documents as a proof of the offered Technical Specifications will result in a non-compliant offer on Line Item basis.

EOI INSTRUCTIONS

1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace (<u>www.ungm.org</u>) with the UN Secretariat in order to be eligible to participate in any solicitation. Information on the registration process can be found at <u>https://www.un.org/Depts/ptd/vendors</u>.

Prerequisites for Eligibility

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
 - I. the Compendium of United Nations Security Council Sanctions Lists (<u>https://www.un.org/securitycouncil/content/un-sc-consolidated-list</u>), or
 - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary of affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15).
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.

For Registered Vendors: Vendors already registered at the UN Global Marketplace with the UN Secretariat must ensure that the information and documentation (e.g. financial statements, address, contact name, etc.) provided in connection with their registration are up to date in UNGM. Please verify and ensure that your company is registered under its full legal name.
