The United Nations Interim Force in Lebanon (UNIFIL) has a mandate to support the implementation of the Security Council Resolution 1701. As part of the Mission's support programme, the United Nations Interim Force in Lebanon (UNIFIL) is seeking Expressions of Interest (EOI) from fully qualified companies wishing to be considered for inclusion in a tender for the following:

Establishment of Long Term Agreement/contract for the provision of Security Services for UNIFIL House Baabda (Mount Lebanon) for an initial period of Two (2) Years with possible extension for an additional Three (3) One-Year period (1+1+1 Year).

UNIFIL has a requirement for the establishment of Long Term Agreement/contract for the provision of Security Services for UNIFIL House Baabda (Mount Lebanon) for an initial period of Two (2) Years with possible extension for an additional Three (3) One-Year period (1+1+1 Year).

The Contractor shall ensure the following services:

- 1- Ensure security services for UNIFIL House located in Baabda (Mount Lebanon), including unarmed security guards and equipment 7 days/24 hours/day including weekends and holidays.
- 2- Provide all necessary personnel, supervision and other equipment , materials, consumables and supplies to ensure the fulfillment of the obligations.
- 3- Provide competent security guards to manage the access of people and vehicles into UNIFIL House (including screen, registering, monitoring, ID checks, Visitors escorts and other related tasks).
- 4- Conduct daily schedule regulations ground control inside and outside UNIFIL premises.
- 5- Enforcing parking regulations,
- 6- Reporting any security incident,
- 7- Inspecting all vehicles accessing UNIFIL House,
- 8- Ensure staff uniform, materials and tools (such as walkies-talkies, protection sticks, mirrors for under vehicles inspection, hand-held metal detectors, etc..).
- 9- In addition, the Contractor shall comply with following:
  - a- Provide all services required by its personnel in accordance with Local Labor Law,
  - b- Adhere with the instructions received from UNIFIL Security Section, to ensure the access control duties.
  - c- Detect any risk of fires or presence of any suspected presence of bomb / explosive threats.
  - d- Other tasks to be detailed in the Scope of Work.

UNIFIL intends to launch a Request for Proposal to qualified companies including those who will respond to this Expression of Interest. The full technical requirement and details will be included in the solicitation document. The solicitation document will be sent to those vendors who are registered in UNGM (United Nations Market Place), or at least have commenced the process to register with the UNGM. All interested companies must be registered in the UNGM at LEVEL 2.

Interested companies must complete the Vendor Response Form and return it to the attention of UNIFIL Chief Procurement Officer. Your response must be submitted not later than 04:00 PM Eastern European Time (Local time in Lebanon) on 07 November 2018, via (a) E-mail to [unifil-eoi@un.org](mailto:unifil-eoi@un.org); or (b) Facsimile to +961 1 925022.

Responding to this Request:

1. For this purpose, UNIFIL will undertake a competitive bidding exercise shortly and consider inviting those companies that have expressed their interest and provided initial relevant information as to their

ability to fulfil UNIFIL's requirement. Please note. This is not an invitation for submission of a price proposal.

2. Vendor Response Forms must be completed in full and supported by the requested information providing the evidence of the company's ability to satisfy UNIFIL's requirement. The UNIFIL reserves the right to reject Expressions of Interest documents that are incomplete, or are received after the stated deadline.

3. Companies that are not registered with UNGM cannot be included in the List of Invitees. Only those companies that are registered at Level 2 would be eligible for award of contract pertaining to this requirement. Registration with UNGM ([WWW.UNGM.ORG](http://WWW.UNGM.ORG)) is free of charge and mandatory for all companies wishing to participate in the UN solicitations.

- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;

Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15).

Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.
