DESCRIPTION OF REQUIREMENTS

The United Nations Interim Force in Lebanon (UNIFIL) has a mandate to support the implementation of the Security Council Resolution 1701. As part of the Mission's support programme, the United Nations Interim Force in Lebanon (UNIFIL) is seeking Expressions of Interest (EOI) from fully qualified companies wishing to be considered for inclusion in a tender for the following:

SALE OF SURPLUS UNUSABLE WITTEN-OFF PREFABS

The United Nations Interim Forces in Lebanon (UNIFIL) has surplus unusable written-off prefabs for sale, located at various positions in its Area of Operation (AO) in Lebanon. In order to ensure regular and timely collection of written-off prefabs, UNIFIL intends to establish a contract for one (1) year period with an option for further extension of two (2) one (1) year each thereafter, at UNIFIL's discretion, and under the same terms and conditions.

The surplus unusable written-off prefabs is offered for sale 'AS IS' and 'WHERE IS', and without recourse or warranties of any kind. The unusable written-off prefabs are currently located in the Scrap Yard at UNIFIL HQ Naqoura, and throughout UNIFIL AO. Locations may change at any time and the awarded contractor will be notified in advance of any such changes. The awarded contractor will be required to collect the unusable written-off prefabs on 'as and when required basis', and will be informed ten (10) days in advance of such need, by the UNIFIL Chief Property Management Section, and/or his designate.

For the purpose of establishing a contract, UNIFIL will undertake a competitive bidding exercise shortly and consider inviting those companies that have expressed their interest and provided initial relevant information

as to their ability to fulfill UNIFIL's requirement. Site Visit shall be organized by the Procurement Office, UNIFIL, as part of the bidding exercise. Please note, this is not an invitation for submission of a price				
proposal.

EOI INSTRUCTIONS

1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace (www.ungm.org) with the UN Secretariat in order to be eligible to participate in any solicitation. Information on the registration process can be found at https://www.un.org/Depts/ptd/vendors.

Prerequisites for Eligibility

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
 - I. the Compendium of United Nations Security Council Sanctions Lists (http://www.un.org/sc/committees/list_compend.shtml), or
 - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary of affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15.
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.

For Registered Vendors: Vendors already registered at the UN Global Marketplace with the UN Secretariat must ensure that the information and documentation (e.g. financial statements, address, contact name, etc.) provided in connection with their registration are up to date in UNGM. Please verify and ensure that your company is registered under its full legal name.
