## **DESCRIPTION OF REQUIREMENTS**

he United Nations Interim Force in Lebanon (UNIFIL) has a mandate to support the implementation of the Security Council Resolution 1701. As part of the Mission's support programme, the United Nations Interim Force in Lebanon (UNIFIL) is seeking Expression of Interest (EOI) from fully qualified companies wishing to be considered for inclusion in a tender for the following:

Contract for the provision of Post Exchange (PX) Duty Free to UNIFIL, located in Naqoura, South Lebanon, for an initial two (2) years period with an option for three (1+1+1) additional years extension period, depending on the performance and or Mission mandate.

N.B: All interested companies must be registered in the UNGM at LEVEL II in order to be eligible to participate in the bidding exercise.

## Summary of requirement:

1. The United Nations Interim Force in Lebanon (UNIFIL) is seeking a business entity to establish, maintain and efficiently operate a duty/tax-free Post Exchange (PX) facility to provide quality service and sales of wide range of reasonably priced merchandise not easily available in the local market.

2. The layout of the facility should encompass different sections for cosmetics, cosmetics testing area, area for wine and spirits with appropriate temprature levels, sports ware section, and general shopping area. UNIFIL shall provide space and connections\meters to utilities required for PX operation.The diversity of UN personnel/clients has to be taken into consideration, which is currently estimated at 10,500 personnel and may vary from time to time.

3. Companies interested are required to have effective electronic control system with quotamanagement reporting capability; a cost-effective, simple and efficient tracking-system to allocate and control authorized personnel purchases.

# SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

UNIFIL intends to launch a Request for Proposal (RFP) to qualified companies including those who will respond to this Expression of Interest. The full technical requirement and details of the required services will be included in the solicitation document. The solicitation document will be sent to those vendors who are registered in UNGM (United Nations Market Place), or at least have commenced the process to register with the UNGM. All interested companies must be registered in the UNGM at LEVEL II.

Interested companies must complete the Vendor Response Form and return it to the attention of UNIFIL Chief Procurement Officer. Your response must be submitted not later than 04:00 PM Eastern European Time (Local time in Lebanon) on 19 June 2018, via (a) E-mail to unifil-eoi@un.org; or (b) Facsimile to +961 1 925022.

Responding to this Request:

1. For this purpose, UNIFIL will undertake a competitive bidding exercise shortly and consider inviting those companies that have expressed their interest and provided initial relevant information as to their ability to fulfil UNIFIL's requirement. Please note. This is not an invitation for submission of a price proposal.

2. Vendor Response Forms must be completed in full and supported by the requested information providing the evidence of the company's ability to satisfy UNIFIL's requirement. The UNIFIL reserves the right to reject Expressions of Interest documents that are incomplete, or are received after the stated deadline.

3. Companies that are not registered with UMGM cannot be included in the List of Invitees. Only those companies that are registered at Level II would be eligible for award of contract pertaining to this

requirement. Registration with UNGM (WWW.UNGM.ORG) is free of charge and mandatory for all companies wishing to participate in the UN solicitations.
