Org .Setting And Reporting

This position is located in the Building Maintenance Unit sub-unit of the Facility Maintenance Unit under the Engineering & Facility Maintenance Section (EFMS) of the United Nations Interim Force in Lebanon (UNIFIL), Naqoura. The incumbent will report to the Supervisor of the Building Maintenance Unit or his/her designate.

Responsibilities

- 1.Perform tasks related to construction work and prefabricated container installations in UNIFIL, including but not limited to laying out, framing and finishing of new construction and repair structural metal and woodwork and equipment in establishments.
- 2.Perform installation, repair and maintenance of plumbing systems including variety of routine and preventive maintenance of plumbing systems at offices and residential areas.
- 3.Carry out scheduled periodic and emergency maintenance services on installations; perform surveys and ensure the provision of required materials.
- 4.Monitor the tools/equipment and material inventory. Ensure the use of the materials in the most productive manner.
- 5.Liaise with relevant unit(s) supervisors for expert advice on maintenance/construction works, and other technicians, as necessary.
- 6.Perform other functions as assigned by the Unit Supervisor.

Professionalism: Demonstrated technical skills and knowledge and experience in construction, infrastructure and maintenance project implementation. Shows pride in work and in achievements; demonstrates professional competence and mastery of subject matter; is conscientious and efficient in meeting commitments, observing deadlines and achieving results; is motivated by professional rather than personal concerns; shows persistence when faced with difficult problems or challenges; remains calm in stressful situations; Commitment to implementing the goal of gender equality by ensuring the equal participation and full involvement of women and men in all aspects of work.

Candidates who have committed crimes other than minor traffic offences may not be considered for employment.
