**Description of Requirement**

The United Nations Interim Force in Lebanon (UNIFIL) has a mandate to support the implementation of the Security Council Resolution 1701. As part of the Mission's support programme, the United Nations Interim Force in Lebanon (UNIFIL) is seeking Expressions of Interest (EOI) from fully qualified companies wishing to be considered for inclusion in a tender for the following:

**Supply & Delivery of Various Gym and Sports Equipment**

The United Nations Interim Forces in Lebanon (UNIFIL) has a requirement for a one time purchase, for Various Gym and Sports Equipment.

The list of the equipment includes, but it is not limited to:  
Treadmill 6 pcs, Multifunctional Strength Trainer 3pcs, Power Stepper 10 pcs, Tug of War & Jump Rope 14 pcs, Exercise Mat 50 pcs, Chess & Dart Sets 32 pcs, Rackets, Badminton, Lawn & Table Tennis 170 pcs,

Ball, Tennis Ball, Volley Ball, Handball ball, Basket Ball, Football 300 pcs , Nets- Football, Handball, Volleyball, Tennis 40 pcs.

For this requirement, UNIFIL will undertake a competitive bidding exercise shortly and consider inviting those companies that have expressed their interest and provided initial relevant information as to their ability to fulfill UNIFIL's requirement. Please note, this is not an invitation for submission of a price proposal.

Responding to this Request:

1. 2. Vendor Response Forms must be completed in full and supported by the requested information providing the evidence of the company's ability to satisfy UNIFIL's requirement. The UNIFIL reserves the right to reject Expressions of Interest documents that are incomplete, or are received after the stated deadline.
3. Registration with UNGM ([WWW.UNGM.ORG](http://WWW.UNGM.ORG)) is free of charge and mandatory for all companies wishing to participate in the UN solicitations. Companies that are not registered with UNGM cannot be included in the List of Invitees. **Only those companies that are registered at Level 1 would be eligible for award of contract.**
