Org. Setting and Reporting

This position is located in the Life Support Section, General Supply Unit in United Nations Interim Force in Lebanon (UNIFIL), Naqoura. The incumbent will report to the Chief General Supply Unit.

Responsibilities

- Receives authorized on-line requisitions for stores' supplies from Chiefs of Section and Heads of Units.
- Assists in verifying the requisitions in accordance with sections'/units' monthly requirements.
- Assists in monitoring stock of supplies in the stores; assists in conducting regular stock taking of expendable items in the supply stores.
- Assist in developing technical specifications and scope of requirements for acquisition of goods and services.
- Participate in technical evaluation of offers received from Procurement Section.
- Assist in establishment of appropriate stock levels (minimum, maximum, reorder levels, order quantity).
- Perform market research to obtain quotations for Low Value Purchases when required.
- Prepare and submit camp access for the vendors, renewal of vendors ID cards.
- Ensure availability of items in stock and inform supervisor on any shortfall or low stock levels.
- Prepare and submit camp access for the vendors, renewal of vendors ID cards. Escort vendors to the camp when delivering items.
- Assists in raising requisitions for services and items required by the supply Stores; liaises

with offices and sections about the requests received.

- Follows-up and provides updates of requisition status on a regular basis.
- Assists Receipt and Inspection Unit (R&I) in receiving and inspecting goods delivered by vendors and managed by Life Support Unit. Processes internal R&I reports for goods in the Supply Stores.
- Assists in conducting periodic inventory of UN Non-Expendable property and attractive property managed by Supply stores and updates records in the system by processing issue vouchers to individual end users of UN property for purpose of transparency and accountability.
- Assists in preparing write-off requests for property, which is lost, obsolete or damaged in the system.
- Identifies issues and implements solutions as instructed by the supervisor.
- Generates relevant status reports.
- Maintains and monitors relevant databases (e.g., stock levels of various supply items).
- Provides advice on technical matters to the supervisor.
- Organizes, and maintains contract files and Section's manuals.
- Performs other duties as required.

Competencies

Professionalism: Shows pride in work and in achievements. Demonstrates professional competence and mastery of subject matter. Is conscientious and efficient in meeting commitments, observing deadlines and achieving results. Is motivated by professional rather than personal concerns. The term "sexual harassment" means any unwelcome conduct of a sexual nature that might reasonably be expected or be perceived to cause offence or humiliation, when such conduct interferes with work, is made a condition of employment or creates an intimidating, hostile or offensive work environment, and when the gravity of the conduct warrants the termination of the perpetrator's working relationship. Candidates who have committed crimes other than minor traffic offences may not be considered for employment.

Due regard will be paid to the importance of recruiting the staff on as wide a geographical basis as possible.
