**Description of Requirement:**

**[Supply and Delivery of Spill Kit](#)**

The United Nations Interim Force in Lebanon (UNIFIL) has a requirement for one-time Supply and Delivery of Spill Kit with the following estimated quantities.

- 1.) 95 Gallon Overpack on wheels (spill Kit), consists of absorbent pads, soks, disposable bags and gloves etc.- Two Hundred (200)packs
- 2.) Loose absorbent for cleaning up of leaks, oil spills, coolants and water: One Thousand (1,000)pcs

The Products shall be delivered to UNIFIL HQ Naqura, South Lebanon based on delivery terms Delivered at Place (DAP – INCOTERMS 2010).

For this requirement, UNIFIL will undertake a competitive bidding exercise shortly and consider inviting those companies that have expressed their interest and provided initial relevant

information as to their ability to fulfill UNIFIL's requirement. Please note, this is not an invitation for submission of a price proposal.

**Responding to this Request:**

2. Vendor Response Forms must be completed in full and supported by the requested information providing the evidence of the company's ability to satisfy UNIFIL's requirement. The UNIFIL reserves the right to reject Expressions of Interest documents that are incomplete, or are received after the stated deadline.
