Description of Requirement

The United Nations Interim Force in Lebanon (UNIFIL) has a mandate to support the implementation of the Security Council Resolution 1701. As part of the Mission’s support programme, the United Nations Interim Force in Lebanon (UNIFIL) is seeking Expressions of Interest (EOI) from fully qualified companies wishing to be considered for inclusion in a tender for the following:

Supply and Delivery of Electrical Tools (Products) to UNIFIL HQ-NAQ

The United Nations Interim Force in Lebanon (UNIFIL) has a requirement for “One Time Purchase” Supply and Delivery of Electrical Tools (Products) to UNIFIL HQ-NAQ

1. Required items are: Wrenches, Plier Diag Cut, Level Bubble, Torpedo, 225mm(9in), Hacksaw, Bit Set Drill, Step 3pc, Drill Hammer Crdls, Drill Hammer, SDS Rotary 220V, Screwdriver Set, Std Combo 6pc, Plier Side Cut, Drill Hammer Crdls 24V, Torch, Tool Kt: Electrician, Knife Electricians, Driver Ratcheting Skt Wrench, Shears, Brush Wirem, Cutting Discs, Bit Drill, SDS Hammer, Gauge Set Manifold, Plier & Screwdriver Set and other similar items.

2. The Products are required to be delivered to UNIFIL HQ Naqoura, South Lebanon based on delivery terms Delivered at Place (DAP, INCOTERMS 2010).

UNIFIL will undertake a competitive bidding exercise shortly and consider inviting those companies that have expressed their interest and provided initial relevant information as to their ability to fulfill UNIFIL's requirement. Please note, this is not an invitation for submission of a price proposal.

Responding to this Request:

1. 2. Vendor Response Forms must be completed in full and supported by the requested information providing the evidence of the company's ability to satisfy UNIFIL's requirement. The UNIFIL reserves the right to reject Expressions of Interest documents that are incomplete, or are received after the stated deadline.
3. Registration with UNGM (WWW.UNGM.ORG) is free of charge and mandatory for all companies wishing to participate in the UN solicitations. Companies that are not registered with UMGGM cannot be included in the List of Invitees. **Only those companies that are registered at Level 1 would be eligible for award of contract.**
