## Establishment of Contract for Construction of Extension to Existing Hospital Building in UNIFIL HQ camp Naqoura.

The United Nations Interim Force in Lebanon (UNIFIL) has a requirement for a Project for the Construction for an Extension to the Existing Hospital Building in UNIFIL HQ camp Naqoura The project/works shall comprise of the below elements and the successful Contractor would be required to supply all required management, administration, workmanship, transportation, tools& equipment with its related accessories fuel, etc., to complete the works as specified hereunder:

- 9- Special Works: Oxygen Installation, Door signs and others such as preparation of shop and as built drawings.
- 10- Plumbing and Sanitary works.
- 11-Electrical Works.

For the purpose of establishing a contract, UNIFIL will undertake a competitive bidding exercise in the future and consider inviting those companies that have expressed their interest and provided initial relevant information as to their ability to fulfill UNIFIL's requirement.
