DESCRIPTION OF REQUIREMENTS

The United Nations Interim Force in Lebanon (UNIFIL) has a mandate to support the implementation of the Security Council Resolution 1701. As part of the Mission's support programme, the United Nations Interim Force in Lebanon (UNIFIL) is seeking Expressions of Interest (EOI) from fully qualified companies wishing to be considered for inclusion in a tender for the following:

Long Term Agreement for Providing Construction Machines and Site Clearance Equipment in UNIFIL Headquarters and Area of Operation

The United Nations Interim Force in Lebanon (UNIFIL) has a requirement for placement of a Long Term Agreement (LTA) to provide construction machines and site clearance equipment to UNIFIL headquarters (HQ) Naqoura, and to south Lebanon Area of operation (AO) on daily basis for execution of different works; as ground levelling, excavation, transporting construction waste, demolition of existing solid buildings and infrastructure, cleaning the site, etc. using skilled operators and equipment as described below:

- 1. Heavy track-type bulldozers;
- 2. Heavy track-type excavators;
- Heavy wheel-type excavators;
- 4. Skid-Steer Loaders Equipped with Front Bucket;
- Heavy Duty Dump Trucks;
- 6. Heavy Duty Front Wheel Loaders;
- 7. Graders With Ripper And Scarifier;
- 8. Backhoes 4WD with a Backhoe at one end, a front loader on the other end;


- 9. Solid drum vibratory rollers;
- 10. Pneumatic/ hydraulic jack hummer.

Provision of machines and equipment will be determined, on an "as and when required" All works are to be carried out by the contractor.

In support of this requirement, UNIFIL intends to establish a LTA for a period of one (1) year, with possibility of extension for additional two (2) years.

Responding to this Request:

- 1. For the purpose of establishing a LTA, UNIFIL will undertake a competitive bidding exercise shortly and consider inviting those companies that have expressed their interest and provided initial relevant information as to their ability to fulfil UNIFIL's requirement. Please note. This is not an invitation for submission of a price proposal.
- 2. Vendor Response Forms must be completed in full and supported by the requested information providing the evidence of the company's ability to satisfy UNIFIL's requirement. The UNIFIL reserves the right to reject Expressions of Interest documents that are incomplete, or are received after the stated deadline.
- 3. Companies that are not registered with UMGM cannot be included in the List of Invitees. Only those companies that are registered at Level 1 would be eligible for award of contract pertaining to this requirement. Registration with UNGM (WWW.UNGM.ORG) is free of charge and mandatory for all companies wishing to participate in the UN solicitations.

1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace (www.ungm.org) with the UN Secretariat in order to be eligible to participate in any solicitation. Information on the registration process can be found at https://www.un.org/Depts/ptd/vendors.

Prerequisites for Eligibility

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
 - I. the Compendium of United Nations Security Council Sanctions Lists (http://www.un.org/sc/committees/list_compend.shtml), or
 - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary of affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15.
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.

For Registered Vendors: Vendors already registered at the UN Global Marketplace with the UN Secretariat must ensure that the information and documentation (e.g. financial statements, address, contact name, etc.) provided in connection with their registration are up to date in UNGM. Please verify and ensure that your company is registered under its full legal name.
