#### DESCRIPTION OF REQUIREMENTS

The United Nations Interim Force in Lebanon (UNIFIL) has a mandate to support the implementation of the Security Council Resolution 1701. As part of the Mission's support programme, the United Nations Interim Force in Lebanon (UNIFIL) is seeking Expressions of Interest (EOI) from fully qualified companies wishing to be considered for inclusion in a tender for the following:

Provision of Business suits and shirts to UNSCOL

UNIFIL has a requirement for the provision of ready-made Business suits and shirts to UNSCOL, Baabda, Lebanon. The requirement shall be ordered against a Contract.

The Contract shall be on "as and when required" basis for a period of one (1) year with the possibility to extend the contract for a further two-year period. The maximum contract period shall be for three (3) years. The service requires the provision of ready-made business suits and shirts and after sale alteration services.

In support of this requirement, UNIFIL intends to establish a LTA for a period of one (1) year, with possibility of extension for additional two (2) years.

Responding to this Request:

1. Interested companies must complete the Vendor Response Form and return it to the attention of UNIFIL Chief Procurement Officer. Your response must be submitted not later than 04:00 PM Eastern European Time (Local time in Lebanon) on 08 September 2017, via (a) E-mail to unifil-eoi@un.org; or (b) Facsimile to +961 1 925022.

For the purpose of establishing a LTA, UNIFIL will undertake a competitive bidding exercise shortly and consider inviting those companies that have expressed their interest and provided initial relevant information as to their ability to fulfil UNIFIL's requirement. Please note. This is not an invitation for submission of a price proposal.

3. Companies that are not registered with UMGM cannot be included in the List of Invitees. Registration with UNGM (WWW.UNGM.ORG) is free of charge and mandatory for all companies wishing to participate in the UN solicitations.

- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15.
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.
