DESCRIPTION OF REQUIREMENTS

The United Nations Interim Force in Lebanon (UNIFIL) has a mandate to support the implementation of the Security Council Resolution 1701. As part of the Mission's support programme, the United Nations Interim Force in Lebanon (UNIFIL) is seeking Expressions of Interest (EOI) from fully qualified companies wishing to be considered for inclusion in a tender for the following:

The United Nations Interim Force in Lebanon (UNIFIL) has a requirement for the Establishment of Long Term Agreement (LTA) for Construction of Solid Structure Ablutions in UNIFIL HQ Naqoura and Area of Operations

The project/works shall comprise of the below elements and the successful Contractor would be required to supply all required management, administration, workmanship, transportation, tools& equipment with its related accessories fuel, etc., to complete the works as specified hereunder:

- 1- Site Works: Site preparation including mobilization and demobilization, excavation, backfilling.
- 2- Concrete Works: Supply, mix and cast-in-situ of plain concrete in ordinary cement 14MP and mix and cast-in-situ of reinforced concrete in ordinary cement (OPC) TYPE I, 30Mpa.
- 3- Masonry Works: Supply, transport and lay concrete hollow block walls.
- 4- Thermal and Moisture Protection (Waterproofing): Prepare surfaces by providing (1) Bituminous applied polyurethane waterproofing membrane UV resistant and Polyurethane pre-polymer based and protective water proof coating; (2) Bituminous coating, (3) Lay Polyethylene sheet membrane of 200

micron; (4) Provide and fix roof with dome type grating and conical outlet.

- 5- Supply and installation of Doors and Windows (Internal and external): Hinged aluminum doors and hinged aluminum windows with all necessary fixing accessories.
- 6- Finishing works: Cement plastering; Supply and lay of Ceramic tiles, Marble threshold, Pavements (precast tiles of pavements, precast curb stones for pavements), Painting and coatings (internal and external).
- 7- Plumbing and Sanitary works: (1) Supply and fixing of Water supply system and Drainage and vent system; (2) Supply and lay external sewer line from toilets; (3) Fix sanitary plumbing fixtures including connections to water supply and drainage points.
- 8- Electrical Works: Supply and installation of PVC enclosures and cables conduits pipes.

- 2. Vendor Response Forms must be completed in full and supported by the requested information providing the evidence of the company's ability to satisfy UNIFIL's requirement. The UNIFIL reserves the right to reject Expressions of Interest documents that are incomplete, or are received after the stated deadline.
- 3. Companies that are not registered with UMGM cannot be included in the List of Invitees. Only those companies that are registered at Level 2 would be eligible for award of contract pertaining to this requirement.
