### **DESCRIPTION OF REQUIREMENTS**

The United Nations Interim Force in Lebanon (UNIFIL) has a mandate to support the implementation of the Security Council Resolution 1701. As part of the Mission's support programme, the United Nations Interim Force in Lebanon (UNIFIL) is seeking Expressions of Interest (EOI) from fully qualified companies wishing to be considered for inclusion in a tender for the following:

Project Contract for the construction of two (02) Observation Towers / Posts at UNIFIL Area of Operation

The United Nations Interim Force in Lebanon (UNIFIL) has a requirement for establishment a project contract for the construction of two (02) Observation Towers / Posts at UNIFIL Area of Operation, South Lebanon, including structural, finishing, and electrical works. The successful proposer shall provide all supervisory, management, equipment, materials, and other personnel with experience, education, ability and other resources to plan, prepare and execute the construction service

UNIFIL intends to launch an Invitation to Bid to qualified companies including those who will respond to this Expression of Interest. The full technical requirement and details of the required services will be included in the solicitation document. The solicitation document will be sent to those vendors who are registered in UNGM (United Nations Market Place), or at least have commenced the process to register with the UNGM.

Interested companies must complete the Vendor Response Form and return it to the attention of UNIFIL Chief Procurement Officer. Only those companies that are registered at Level 1 would be eligible for award of contract pertaining to this requirement. ### 1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace (<a href="www.ungm.org">www.ungm.org</a>) with the UN Secretariat in order to be eligible to participate in any solicitation. ## Prerequisites for Eligibility

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
  - I. the Compendium of United Nations Security Council Sanctions Lists (http://www.un.org/sc/committees/list\_compend.shtml), or
  - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary of affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15.
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.

**For Registered Vendors:** Vendors already registered at the UN Global Marketplace with the UN Secretariat must ensure that the information and documentation (e.g. financial statements, address, contact name, etc.) provided in connection with their registration are up to date in UNGM. Please verify and ensure that your company is registered under its full legal name.
