#### **DESCRIPTION OF REQUIREMENTS**

The United Nations Interim Force in Lebanon (UNIFIL) has a mandate to support the implementation of the Security Council Resolution 1701. As part of the Mission's support programme, the United Nations Interim Force in Lebanon (UNIFIL) is seeking Expressions of Interest (EOI) from fully qualified companies wishing to be considered for inclusion in a tender for the following:

Establishment of Long Term Agreement (LTA)/Contract for the Provision of Repair and/or Rewinding Services for Water and Wastewater "Grundfos" Pumps for UNIFIL (Contract Period is 1+1 Year).

The United Nations Interim Force in Lebanon (UNIFIL) has a requirement for the Establishment of Long Term Agreement (LTA)/Contract for the Provision of Repair and/or Rewinding Services for Water and Wastewater "Grundfos" Pumps for UNIFIL.

- -The Contractor will render the services on an "as and when required" basis to be performed at the service provider's workshop, pursuant to receipt of UNIFIL's Order. Contractor should provide complete repair, cost including, rewinding materials, spare parts and workmanship etc...
- -UNIFIL shall be responsible to deliver the components for repair and collect back once the repair is completed at the Contractor's premises.
- -UNIFIL may have a need to repair/service additional Electrical components belonging to different type/model of Pumps.

-The Contract shall comprise of the below elements and the successful Contractor would be required to complete the services as specified hereunder:

- 1. Pumps Description:
- A Surface water pumps:

Repair and rewinding of single/multi-stage surface water pumps including replacement of impeller, bearings and water seals etc.

B Submersible sewage pumps:

Repair and rewinding of submersible sewage pumps including replacement of impeller, bearings and water seals etc.

C Submersible deep well pumps:

Repair and rewinding of multi-stage submersible deep well pumps including replacement of bearings and water seals etc.

- 2. The services will include, but are not limited to, the following components on the pumps:
- a) Check, Rewind AC motor,
- b) Check, Repair or Replace Set of Brushers, Contact Points or Clutchers,
- c) Check, Repair or Replace Capacitors and/or Inbuild Floats,
- d) Check, Repair or Replace Set/Unit of Impellers of pump,
- e) Check, Repair or Replace Set of Water Seals,
- f) Check, Repair or Replace Central Axel,
- g) Check, Repair or Replace Set of Bearings,
- h) Check, Repair or Replace Motor Winding Block,
- i) Check, Repair or Replace Complete Motor Housing including Connecting Coupling,
- j) Check, Repair or Replace Complete Pump Housing including External Flanges/Couplings,
- k) Check, Repair or Replace Cooling Fan...


For the purpose of establishing a contract UNIFIL intends to launch an Invitation to Bid to qualified companies including those who will respond to this Expression of Interest. The full technical requirement and details of the required services will be included in the solicitation document. The solicitation document will be sent to those vendors who are registered in UNGM (United Nations Market Place), or at least have commenced the process to register with the UNGM.

Interested companies must complete the Vendor Response Form and return it to the attention of UNIFIL Chief Procurement Officer. Your response must be submitted not later than 04:00 PM Eastern European Time (Local time in Lebanon) on 08 January 2018, via (a) E-mail to unifil-eoi@un.org; or (b) Facsimile to +961 1 925022.

#### Responding to this Request:

- 1. For this purpose, UNIFIL will undertake a competitive bidding exercise shortly and consider inviting those companies that have expressed their interest and provided initial relevant information as to their ability to fulfil UNIFIL's requirement. Please note. This is not an invitation for submission of a price proposal.
- 2. Vendor Response Forms must be completed in full and supported by the requested information providing the evidence of the company's ability to satisfy UNIFIL's requirement. The UNIFIL reserves the right to reject Expressions of Interest documents that are incomplete, or are received after the stated deadline.
- 3. Companies that are not registered with UMGM cannot be included in the List of Invitees. Only those companies that are registered at Level 1 would be eligible for award of contract pertaining to this requirement. Registration with UNGM (WWW.UNGM.ORG) is free of charge and mandatory for all companies wishing to participate in the UN solicitations.
